## **Gender and Development Trends in St Vincent and the Grenadines**

#### Health

Maternal mortality rates in St Vincent and the Grenadines have dropped significantly, from 58 per 100,000 live births in 1990, to 45 per 100,000 in 2015 (WHO, 2015).

#### **Education**

National data for 2010 show a majority of women in all academic courses in St. Vincent and the Grenadines, with especially high female representation in teacher training (81%); nursing (96%); and arts, sciences and general studies (65%) (Caribbean Development Bank, 2014, p. 4).

#### **Economy**

Even though girls and young women in St. Vincent and the Grenadines tend to have higher educational achievements, these results have not yet translated into more and better paying jobs for women, who accounted for 26% of unemployment rates (compared to 12% of men) and tended also to be concentrated in low-paying sectors (Caribbean Development Bank, 2014, p. 4).

#### Governance

Women are well represented in the government of Saint Vincent and the Grenadines as Permanent Secretaries, members of Statutory Boards and Heads of Departments. Under

Section 79 of the Constitution, these persons cannot be removed without the intervention of the Governor General (UN CEDAW Periodic Report, 2013).

Within the Judiciary, women are well represented in Saint Vincent and the Grenadines. There are two High Court Judges, one of which is female (UN CEDAW Periodic Report, 2013).

### **Human Rights**

A 2014 report by OHCHR notes that "the State of Saint Vincent and the Grenadines does not fulfil its obligation to take all appropriate measures to eliminate all forms of discrimination against women" (OHCHR, 2014, p. 5)

Between 2006 and 2009, 205 cases of rape, 200 cases of sex with a minor under the age of 15, and 29 cases of incest were reported in SVG (OHCHR, 2014, p.7).

## St Vincent and the Grenadines SDG Progress Profile

 St Vincent and the Grenadines was not included in the 2016 SDG Index and Dashboards due to insufficient data. According to a 2016 report (Bertelsmann Stiftung, 2016), the data from St Vincent and the Grenadines was missing 47% of the values needed to be ranked, and therefore was not included in any indicator data (Annex 2, p. 39)
